

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.kskservices.com](http://www.kskservices.com) and KSK Professional Services and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to KSK Professional Services include [www.kskservices.com](http://www.kskservices.com) and KSK. The KSK website is a service site. By using the KSK website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through KSK's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

### **Sharing Information with Third Parties**

KSK does not sell, rent or lease its customer lists to third parties.

KSK may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to KSK, and they are required to maintain the confidentiality of your information.

KSK may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on KSK or the site; (b) protect and defend the rights or property of KSK; and/or (c) act under exigent circumstances to protect the personal safety of users of KSK, or the public.

### **Tracking User Behavior**

KSK may keep track of the websites and pages our users visit within KSK, in order to determine what KSK services are the most popular. This data is used to deliver customized content and advertising within KSK to customers whose behavior indicates that they are interested in a particular subject area.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by KSK. This information can include: your IP address, browser type, domain names, access times

and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the KSK website.

### **Use of Cookies**

The KSK website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.
